The SIEF communication is organized by ReachCentrum on behalf of the lead registrant. SIEFreach is the chosen communication platform.

A SIEF survey was done in the period between April, 21st and May, 28th 2010 with two requests to respond send out to all pre-registrants of the substances Potassium

tetrafluoroaluminate (EINECS 238-485-8) and Aluminium potassium fluoride (EINECS 262-153-1). Only 24 legal entities from 199 active pre-registrants answered on the survey.

The following table gives an overview on the registration intentions (double counts are possible!):

On this basis the consortium members decided that the mono-constituent Potassium tetrafluoroaluminate (EINECS 238-485-8) **will not be registered for the 2010 deadline**, but will be supported for the 2013 deadline.

The two multi-constituent compositions will be registered based on the description of Aluminium potassium fluoride (EINECS 262-153-1) for the 2010 deadline.

Each company shall check that the required pre-registrations are done! This is not the case based on the survey results and the data in REACH-IT. The multi-constituent SIPs no. 1 and no.2 are covered by EINECS 262-153-1. The mono-constituent SIP no.3 is covered by EINECS 238-485-8.

The consortium intends to share the full dossier including CSA and CSR. The jointly prepared CSR will be an optional part which has to be individual issued to ECHA. The CSR will be prepared for the list of uses published on the [consortium website](http://www.reachcentrum.eu/EN/consortium-management/consortia-under-reach/fluoroaluminates-reach-consortium.aspx).
